#### **Preface:**

The knowledge and understanding of the value of democracy, citizenship, governance and human rights is always a major point of concern for human being in different societal relationship including power and authority sharing. It has been an important area of academic disciplines to study and understand how individuals and societies inhibit and coexist in a given environment, which are being knitted by various complex equations of interest and authoritative allocation of values. Hence, Political Science as adiscipline of study today is not confined to the study of government and constitution only, but all the human relationship across the countries and societies that can be defined in terms of interest, power and obligations. In Indian context, study of politics even much more complex in view of its multi-cultural ethnic societies, diverse socioeconomic conditions and heterogeneous geo-strategic locations. The primary objective of offering Political science as a minor subject in the FYUGP Curriculum of the Majuli University of Culture is to build a primary but concrete foundation of understanding the politics and political science, which will help the students to inculcate their democratic values, enhance the consciousness of their rights and duties, make them vigilant, alert, intelligent, patriotic and universal. In order to upgrade the existing CBCS in the Universities through providing more flexibility, multi- or inter-disciplinarily in the curriculum, the UGC has developed 'Curricular Framework and Credit System for

Cooperation and Multicultural Competence: The students should be able to work collaboratively in dealing with the political issues and challenges of contemporary time in establishing peace, equality and justice in a post-colonial, developing country like India.
