**MAJULI UNIVERSITY OF CULTURE ORDINANCE FOR CONDUCT OF
ENTRANCE TEST FOR ADMISSION TO THE VARIOUS POST
GRADUATE PROGRAMMES OF MAJULI UNIVERSITY OF CULTURE,
MAJULI - 2023**

1. Title:

This Ordinance shall be called the 'Majuli University of Culture Ordinance for conduct of Entrance Test for Admission to the various Post Graduate Programmes of Majuli University of Culture, Majuli, 2023'. This Ordinance shall come into effect from the academic session 2023-2024.

2. Definition:

- a) 'Department' means a Department of Majuli University of conducting different academic programmes in the Choice-based Credit System, Majuli University of Culture, Majuli 2023).
- b) Entrance Test means the Examination conducted by the University to select eligible candidates for admission to the various Post Graduate Programmes conducted by the Departments of Majuli University of Culture Majuli as per the provisions of this Ordinance.
- c) The Entrance Test shall be called Majuli University of Culture Entrance Test, hereinafter shall be called as MUCET.

3. Objectives:

- a) This Ordinance has been framed to regulate the procedure for admission to the various Post Graduate Programmes of Majuli University of Culture conducted by the Departments of Majuli University of Culture.
- b) This Ordinance is framed to streamline the Admission Procedure of the various Academic Programmes as envisaged by the guidelines of the UGC.

4. Extent of Application:

- a) This Ordinance shall be applicable to the admission to the all Post Graduate Academic Programmes conducted by the Departments of Majuli University of Culture.
- b) This Ordinance shall comply with the existing Majuli University of Culture Reservation and Relaxation Rules of the Post Graduate Programmes conducted by the Teaching Departments of the University.

5. Selection of Candidates:

The MUCET shall be conducted for all candidates of all the academic programmes irrespective of the University they have passed the qualifying examination.

6. Conduct of MUCET and Functions of the MUCET Board:

7.

- a) The MUCET shall be conducted by the MUCET Board constituted by the Vice-Chancellor from time to time.
- b) The MUCET Board shall take necessary action for conducting the MUCET with approval from the University.
- c) The MUCET Board shall recommend the schedule, budget and all other relevant aspects for smooth conduct of the Test.
- d) The Chairperson and Member-Secretary shall appoint the persons for different confidential and administrative assignments like question paper setter, evaluator, observer, etc. from the panel of the same approved by the Vice-Chancellor.
- e) The MUCET Board shall extend necessary support to the in the admission process as and when necessary.
- f) The MUCET shall be normally held in the second/ third week of June every year as per the schedule notified by the University from time to time. In special circumstances, the schedule may be changed.

8. Notification of the MUCET:

- a) The candidates appearing the final semester examinations or have cleared the relevant qualifying examinations are eligible to appear in the MUCET.
- b) The intending candidates shall have to apply online for appearing the MUCET with a payment of a prescribed fee as per the notification of the University.

- c) On recommendation of the MUCET Board, the Registrar shall issue the Notification of the MUCET and Admission to the Post Graduate Academic Programmes.

9. Nature of the MUCET:

- a) The MUCET shall be of 100 Marks and of One Hour Thirty Minutes duration.
- b) It shall be conducted in a single paper of the concerned subject containing 50 Objective Type Multiple Choice questions carrying 2 (two) marks each.
- c) The Question Paper shall be in English excluding the language subjects.
- d) There shall be a provision of negative marking of .50 mark for incorrect response to a question.
- e) The candidate shall be required to appear the MUCET in the Response Sheet issued during the Examination.
- f) The MUCET score shall be valid for admission in the current academic session only.

10. General:

- a) In the Process of its execution, keeping the spirit intact, the MUCET Board may reinterpret the clauses of the Ordinances as and when necessary.
- b) For any matter not covered under this Ordinance, the existing University Rules, Ordinances, Statutes and the Majuli University of Culture Act, 2021 (as amended) shall be applicable.
